Emergency Number Management

Safety First – Always

Maintenance of an emergency number is a legal obligation:

- 1.) Annex II of REACH requires an emergency number in Section 1.4 of the safety data sheet (SDS).
- 2.) Transportation of hazardous goods requires specification of an emergency number in the shipping documents or on the label.

The exact procedure differs from country to country. Almost all countries require that the emergency number be staffed 24x7 by someone who can provide medical information in the national language. Establishment of such an emergency number requires great effort for companies that operate internationally. That's why we're pleased to provide this service for you if we create your SDSs.

Emergency Number Service for Your Product

Emergency numbers can save lives. You are safe with us as your partner. Whether the number is given on an SDS or in international shipping documents, we make sure that you can be reached if the need arises – in every country in the world where your product is being transported.

National Emergency Number

If an accident occurs that involves a chemical or a mixture, immediate medical help from an emergency number saves lives. The poison control centers in Germany offer this service, but only when contracted to do so. We have signed such a contract with our partner, the Poison Control Center Göttingen. You can also benefit from this added value. At your request, we handle all the required formalities with the poison control center (PCC). We add the emergency number to the SDS, transmit it to the PCC, and, if needed, update the SDS for you.

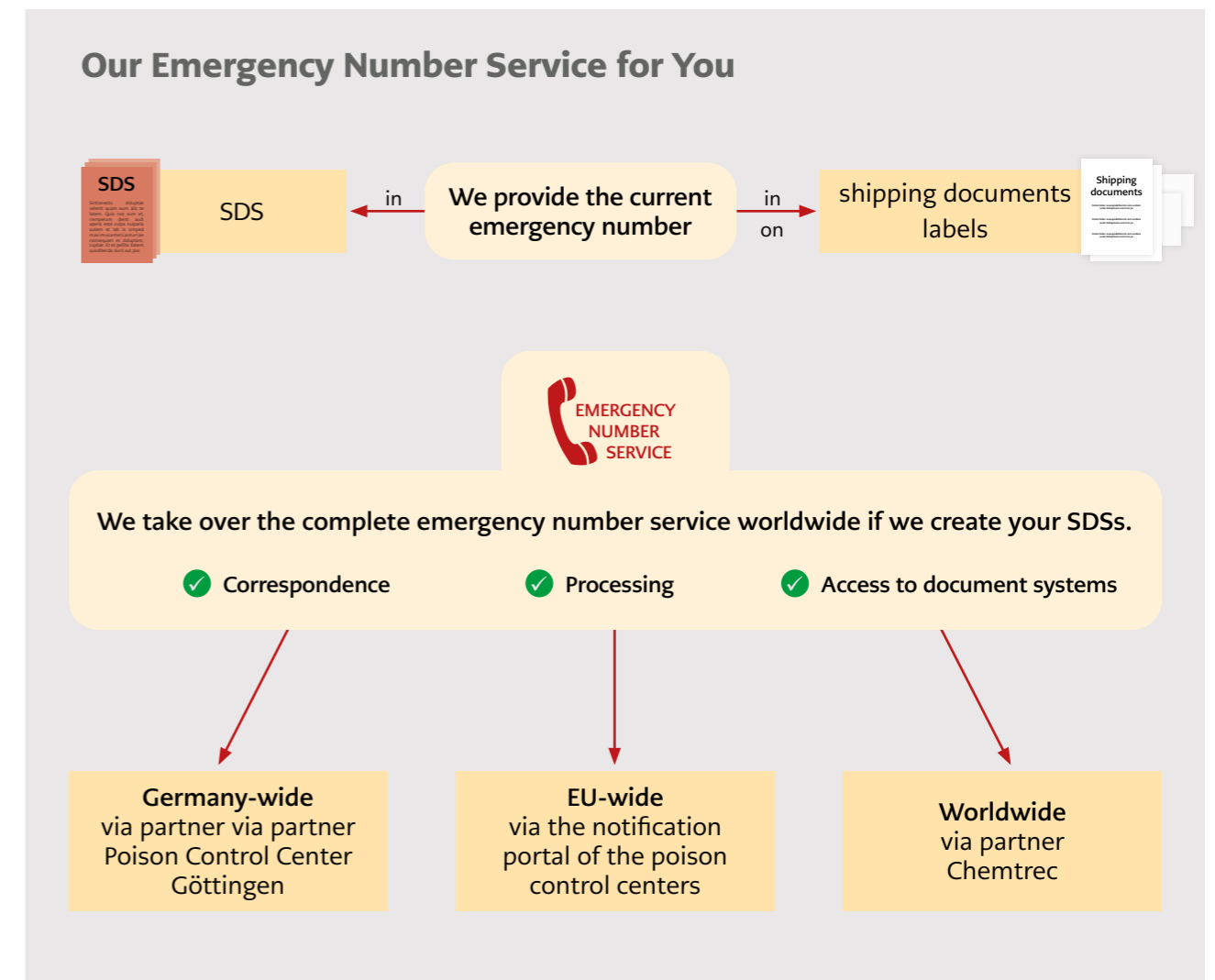
International Emergency Number

Every EU member state commissions a national PCC that provides expert medical information if needed. We know which national agencies are responsible for the centers and handle the required service management.

Our experts can also handle matters when transportation occurs outside the EU. We work with service providers around the world and support you during one-off deliveries of your product as reliably as we can with an unlimited number of deliveries around the world for your entire company.
