# We ensure the legal security of your hazardous mixtures

When you operate as a manufacturer, importer, and/or distributor of hazardous mixtures and want to market them, you must report on their recipes and ingredients to the appropriate national agencies. In Germany, for example, the Federal Institute for Risk Assessment (BfR) is responsible. However, each country operates with a different reporting process. That's why the EU has implemented EU Regulation 2017/542, Annex VIII to set uniform rules and deadlines across Europe.

For consumer products (private use) as well as for products for commercial and industrial end use, the relevant notification deadlines must be observed (see diagram).

## On-Time Reporting on Mixtures

Even though product reporting is to be implemented uniformly across Europe in the future, the reporting process remain complicated. And you probably have plenty of questions, such as: What dates apply to my product mixtures? What regulations must I follow for the Unique Formula Identifier (UFI)? How do I proceed with a report? We show you how best to handle the reporting process and maintain the marketability of your products.

#### (Legal) Security for Hazardous Mixtures

According to Article 45, Annex VIII of the CLP regulation, manufacturers, importers, and/or distributors are mandated to report hazardous mixtures to national agencies and provide them with data on the chemical composition, the chemical identity, concentration, toxicology, and product category. The agencies then redirect this information to the poison control centers in each country. In an emergency, medical personnel can therefore react quickly and take life-saving measures.

The reporting procedure differs from country to country. Some countries require only the safety data sheet, while others require downloading of a specific program to create the reporting documents.


In Germany, for example, you can report your data directly to the BfR or use the ECHA Submission Portal (PCNP). The latter is recommended when you want to market your product mixtures in multiple EU member states.
